BARBER APPRENTICESHIP APPLICATION

INSTRUCTIONS

This is an application for an individual to enroll in the Barber Apprenticeship Program in the State of West Virginia. This application must be completed in its entirety. Incomplete applications will be returned to the applicant. This application must be received at least 20 days prior to the Apprentice's anticipated start date. After the application has been received by the Board's office, a Board Inspector will contact the Barber Apprenticeship Provider at the telephone # provided on the "Barber Apprenticeship Provider Requirements" section to schedule an inspection of the salon or shop in which the Apprentice will be training. **Please be advised that the applicant is not authorized to start the Barber Apprenticeship Program until an inspection of the salon or shop has been completed and approved by a Board Inspector.** If the salon or shop passes inspection, the applicant will be issued an official Barber Apprentice Permit and he or she may start the program upon receipt of their permit. The rules that govern the Barber Apprenticeship program are W. Va. Code § 30-27-8a and Series 13 of the Board's Legislative Rules.

Upon inspection, the applicant must have an adequate supply of equipment to be approved to start the Barber Apprenticeship Program. The minimum amount of equipment that must be located within the salon or shop at the time of inspection is as follows:

- Two (2) Individual Work Stations and two (2) functional, hydraulic chairs (1 for the Apprentice & 1 for the Barber)
- One (1) Mannequin Head
- One (1) Milady or Pivot Point Barbering Textbook that has been published within the last five (5) years
- One (1) Cape
- One (1) Container of Shaving Cream
- One (1) First Aid Kit
- One (1) Container of Clipper Blade Disinfectant
- Five (5) or more Neck Strips or Towels
- One (1) Neck Brush
- Twelve (12) Combs and six (6) Brushes
- One (1) set of Clippers with assorted blades
- One (1) Shear/Scissor
- One (1) Straight Razor
- One (1) Dip Sterilizer
- One (1) Sign located at the Apprentice's station to read as follows: "Barber Apprentice"

- Has a valid e-mail address and can submit the Apprentice's monthly hours electronically to the Board's office by the 10th of each month in Excel format (an Excel spreadsheet will be sent by the Board to the Apprenticeship Provider's e-mail address after the salon/shop has passed inspection)
